Section 2 - 2018 Proposed Special Standing Rules

- 1. The Convention shall adopt the Tentative Daily Agenda printed in the Convention Workbook Part II.
- 2. The chair shall see that the agenda is followed as closely as possible.
- 3. Resolutions of each floor committee shall be prioritized by number and shall normally be presented in the numerical sequence published in the Convention Workbook Part II.
- 4. Each member of the convention, when recognized by the chair, shall (a) state his name, (b) the name of his congregation or administrative unit he represents, and (c) the city or town where it is located.
- 5. Any person eligible to speak is limited to one time on any given issue and to two minutes except for the person or committee who made the motion, who will be entitled to two minutes after debate is closed.
- 6. In order to ensure that Advisory Delegates have an opportunity to advise the convention on resolutions, when debate begins on a new or substitute resolution and an Advisory Delegate is at a microphone reserved for the Advisory Delegates, the Chairman of the Convention will call upon an Advisory Delegate to speak first to the issue at hand.
- 7. A delegate who speaks on an issue may not move to call the question at the close of his or her speech.
- 8. While any voting delegate may call the question at any time, after every 30 minutes of debate on any one motion there shall be an automatic call of the question by the chair.
- 9. Instead of only a voice vote on motions before the convention, the chair may also call for a keypad vote or raising of the right hand.
- 10. If a substitute motion is offered and seconded, the presenter shall be offered two minutes to provide the rationale for offering it, and a member of the floor committee shall be offered two minutes to present rationale for not considering the proposed substitute, after which the convention shall decide by majority vote without further debate whether or not to consider the substitute.
 - If the decision is in the affirmative and if the substitute motion is subsequently adopted, the original motion fails.
 - If the substitute motion does not receive favorable action either to consider or to adopt, the original motion is again considered. (This is an adaptation of the so-called "Behnken Rule" for addressing substitute motions used at the Synodical Convention.)
- 11. Whenever possible, substitute resolutions and amendments to proposed resolutions shall be submitted to the Secretary in advance of the proposed resolutions' introduction to the convention. When this is not possible, a written copy of the proposed substitute motion or amendment shall be provided to the Secretary immediately after it is offered from the floor.
- 12. Any amendment exceeding ten (10) words must be submitted in writing to the chair.
- 13. A motion to close debate ("call the question") shall apply only to the immediately pending question.
- 14. Questions of privilege shall be addressed in writing to the chair, or its appointee, instead of consuming convention time.

- 15. In the sessions of the last day, the chair shall have the privilege of calling up for action resolutions which, in his judgment, must be acted upon by the convention before adjournment.
- 16. Out of respect for others, and in order to promote an orderly and non-distracting convention atmosphere, the following guidance shall apply to the use, and area of use, of electronic equipment, including wired and wireless communication devices, laptops, tablets, cell phones, smart phones, pagers, PDAs, or other similar devices. In all cases where use is permitted, the sound-producing capabilities of such devices shall not be used. (NO personal extension cords will be allowed on the convention floor.) Please see chart below.

- 17. The Convention will be streamed via an online service that both broadcasts and archives the video and audio of the proceedings. Portions of the convention will be made available online for post-convention on-demand viewing. Participant Release: Participants who choose to engage in the proceedings of the convention give the Michigan District, LCMS implicit permission to record, broadcast, transcribe, and publish the audio and video. No releases are required.
 - <u>Recording Authorization</u>: Unauthorized audio and/or video recordings of the Convention proceedings
 are strictly prohibited. Permission to record must be sought prior to the recording process. Private
 recording is not allowed without written permission. The Convention Chair is authorized to request that
 the recording be stopped.
 - <u>Transcriptions</u>: Approval must be obtained from Convention Chair with the understanding that the recording is ONLY for transcription purposes unless otherwise cleared (as in the policy above).
 - <u>Transcription Publication</u>: Publication of any record requires the approval of all participants whose material is represented in the record. Permission request and subsequent authorization is the exclusive responsibility of the requester.
 - <u>Copyright</u>: The Michigan District of The Lutheran Church–Missouri Synod maintains ownership of the copyright.
- 18. No new business or motion for reconsideration may be offered in the afternoon of the last day of the Convention. New business includes, but not exhaustively, substitute motions and original overtures.
- 19. Unless covered by these Special Standing Rules, parliamentary procedure shall be governed by the most recent edition of *Robert's Rule of Order Newly Revised*.

DISTRICT PRESIDENT'S REPORT



The theme for the 2018 Convention of the Michigan District of The Lutheran Church—Missouri Synod completes our emphasis on Synod's 3 foci (Witness, Mercy. Life Together) with Witness, under the theme of "IMAGINE ... Living as God's Saved and Sent Servants." This theme recognizes, encourages, and highlights our life and ministry as "Witness," that is, testimony and demonstration of the reality of God's saving love and power ... inside, but especially outside, the walls of our congregations. As we discover in Holy Scriptures, "Witness" is a part of our DNA. Jesus states, "you are the salt of the earth" (Mt. 5:13) and "you are the light of the world" (Mt. 5:14); and the Holy Spirit inspired the great Apostle to write to us in Philippians 2:15: "shine as lights in the world," as "blameless and innocent, children of God without blemish in the midst of a crooked and twisted generation." The 2018 convention theme, like the previous two Michigan District Convention themes (2012 and 2015), is undergirded and based on Ephesians 3:20-21: "Now to Him who is able to do immeasurably more than all we ask or imagine, according to His power that is at work within us, to Him be glory in the church and in Christ Jesus throughout all generations, for ever and ever! Amen."

To more fully understand the fullness and direction of the 2018 Michigan District Convention theme, it would be good to review the last two convention themes. The theme of the Michigan District 2012 Convention—"IMAGINE...Living as God's Forgiven and Forgiving Family"—emphasized "Life Together," a fellowship of the saints here below but also with those above in heaven. We are at our best when we live in the strength of the Lord and share His forgiveness with one another. That forgiveness and fellowship serve as a marvelous witness to a watching world. "IMAGINE ... Living as God's Loved and Compassionate Community" was the theme for

the 2015 Convention of the Michigan District. We are not only to show "Mercy" to one another within the body of Christ, but also to those who are not yet a part of our congregations. We demonstrate and share mercy; we invite and welcome through acts of mercy because Christ extends Himself through us by revealing and demonstrating His love.

This report is presented with the hopeful, prayerful outcome that we *IMAGINE* what our congregations and members would look like if they deliberately live and act in faith as God's "Saved and Sent Servants." May our faith and attitude reflect the vision of a "People of Hope" inspired by our dependence on, devotion to, and commitment to the Word of God, worship, prayer, and each other that moves us to share the love of Christ with our family, friends, neighbors, communities, and the world.

District Ministry Direction



This past triennium began with the Michigan District Board of Directors reviewing the Board Policy Manual. We thank God for this guidance and direction as the board, made up of elected members—one pastor, one commissioned worker, and two lay people from each of the District's

four regions, met to look over the Michigan District Mission Statement, Vision Statement, and the Critical Targets. The Mission Statement, reflecting the Synod Mission Statement, is: "In grateful response to God's grace and empowered by the Holy Spirit through Word and Sacraments, the mission of the Michigan District of The Lutheran Church—Missouri Synod is vigorously to make known the love of Christ by word and deed within our churches (congregations), communities, and world" which fits perfectly with our 2018 Convention theme.

Our District **Vision Statement** is one of confident, hope-filled direction that comes from faith in Jesus Christ. It reads, "Our congregations are filled to overflowing with people of HOPE! Our living hope, indeed our joyful and confident life and witness to the world, comes from the transforming power of the Gospel and the resurrected Christ who has graced us with an inheritance that can never perish, spoil or fade—kept in heaven for ALL who believe

in Him as Savior and Lord (1 Peter 1:4). This living hope inspires our dependence on, devotion to, and commitment to the Word of God, worship, prayer, and each other that moves us to share the love of Christ with our family, friends, neighbors, communities, and the world in word and deed."

These <u>Mission</u> and <u>Vision Statements</u> guided the direction of our planning and activities as we prepared for, and executed, ministry. Striving to take the love of Christ into the world, our ministry direction is also framed by four **Critical Targets**, which were established by the Board of Directors. "Critical Targets" inform our District staff as to what the Board would like accomplished and established. They also serve as one tool for monitoring and measuring staff ministry.

The first Critical Target is **Great Commission Ministry**. Being *People of Hope*, Michigan District congregations and ministries will share the Good News of Jesus with people who do not know him.

The second Critical Target recognizes the importance of living out the Great Commission through **Great Compassion Ministry**. This Critical Target specifically reads: Being *People of Hope*, Michigan District congregations and ministries will seek out and compassionately attend to people in need.

In the third Critical Target, **Healthy Congregations** are the focus. Healthy congregations intentionally bring Jesus to their communities and beyond and then bring their communities to Jesus in their congregations, especially through Word and Sacrament ministries. The third Critical Target reads: Being *People of Hope*, Michigan District congregations have Christ-centered ministries, loving and joyful atmospheres, and sustainable organizational systems.

The fourth and final Critical Target, **Healthy Church Workers**, recognizes and encourages the Godpleasing efforts of our professional church workers as we thank and praise God for them! Being *People of Hope*, Michigan District church workers have Christcentered lives, loving and joyful spirits, and stable family and professional systems.

District Organization and Structure

As the District staff focuses upon the four Critical Targets and works to accomplish them, the Board of Directors uses a series of outcomes to monitor District ministry and, where possible, to measure it. Reports on the Critical Targets are presented at each Board of Directors' meeting.

In addition to the ecclesiastical supervision and administration of the President's office, there are

five other departments that are overseen. The five departments are:

- Congregation Mission and Ministries
- Lutheran Day Schools
- Communications
- Development
- Business/Finance

Reports from each of these departments are included in Workbooks I and II. We thank God for the men and women who lead these departments and for the privilege of serving the Michigan District together in ministry. However, please allow me to share a few particular highlights:

The *Here We Stand* ministry campaign—which recognizes the 500th Anniversary of the Reformation and Martin Luther's God-given love for, and bold defense of the Good



News of the Gospel, and the future of those bold proclamations for generations to come—was passed at our last District Convention in 2015. Here We **Stand** will continue as a major emphasis within the Michigan District. Mr. Ray Zavada, who heads up this ministry effort, is as tireless in his hard work as he is creative in his encouragements and motivations for all to experience the blessing of participation. Who can forget the Here We Stand 500th Anniversary Service at the Breslin Center: the different choirs that supplied special music before and during the service; President Patrick Ferry's inspiring message: "Here We Stand; And Here We Go;" our little South African friend's big "sending" words; the singing of "A Mighty Fortress Is Our God" by more than 13,000 brothers and sisters in Christ which still echoes in our hearts and minds; and the regional ingathering of goods to bless numerous ministries in the greater Lansing area? (Special thanks to Rev. Dr. Robert Kasper and his team for this amazing service.) Together, may we continue to thank the Lord and look forward to other such occasions for worship and celebration. To date, about one third of all congregations of the District are participating in the campaign. We look forward to all congregations participating in whatever way God inspires them to do so.

Recognizing that ministry is accomplished at the congregational level, our Congregation Mission and Ministry Facilitators (CMMFs) continue to work in geographical zones to strengthen faith-filled ministry efforts among local congregations in their zones. They pray for, look for, and encourage creative, cooperative, and coordinated ministry efforts among their congregations which reach the

lost and disciple the saved. Recognizing the vital importance of our mission and evangelism efforts in all of our congregations, Rev. Bill Woolsey and the FiveTwo Network were contracted to help us see, and prayerfully discover and develop, unique ministry opportunities—and even find the resources to begin and accomplish them-that would facilitate new relationships with as many individuals as possible wherever God has "planted" us. Serving others in love as God served and saved us in His perfect love is what He called us to do wherever we are living. These new relationships prayerfully allow a sharing of the Good News of Jesus Christ—crucified and risen for the sins of the world—with those that God allows us to serve. How blessed are we that the Holy Spirit has gifted ALL His children—laity and church workers alike—with particular gifts, aptitudes, and abilities that He desires to use so that we may "shine as lights (stars) in the world" (Phil.2:15)—a lost and dying world.

Rev. Todd Jones, called from Concordia Seminary, St. Louis, not only continues the efforts of Rev. Bill Woolsey, but is charged with Mission Education and Support in the District, helping us to discover, develop, expand, and educate the District about relevant, sustainable, and exciting mission, outreach, and evangelism opportunites. Having joined us in July of 2017, what a tremendous blessing he has already been to the Michigan District!

During the past triennium, a task force/study group known as the Youth Summit was put together to examine youth ministry in the present and especially, where possible, for the future. The dominant question was, "What would be needed and what would we like Youth Ministry to look like in the year 2030 if we had opportunity to influence a preferred outcome and future?" Inevitably, the Youth Summit tasked itself with determining both (a) a clearly defined preferred future for youth and youth ministry in our congregations and District; and (b) a clear path on how to get there. Members and contributors for the Summit came not only from District congregations but also from around Synod. We hope to both share and implement the outcomes that were determined. There is the possibility that this could take place at our District Convention, and certainly will be shared in the near future.

Other Thoughts and Considerations...

During the past three years, God has been gracious in His leading of the Michigan District in many different ways. He continues to bless us under the direction and encouragement found in *Psalm 9 verse 1: "I will give thanks to you, Lord, with all my heart; I will tell of all your wonderful deeds."* The following is a brief, but not exhaustive, review of a number of those

"wonderful deeds" and blessings. Please join me in giving thanks to the Lord for ...

Our Michigan District congregations, their lay leaders and members, who regularly come together to worship our Lord and Savior, celebrate the Sacraments of Holy Baptism and the Lord's Supper, and continue to be equipped to carry on the work of ministry and service, "so that the body of Christ may be built up until we all reach unity in the faith and in the knowledge of the Son of God and become mature, attaining to the whole measure of the fullness of Christ" (Ephesians 4:12, 13). Having been in many of our congregations over the past three years, I continually give thanks to the Lord for their unique characteristics, their diversity of gifts and assets, and particularly for their individual beauty as "the bride of Christ." Yet, I am also grateful for our common confession of faith, our unity in the Gospel, and our Holy-Spirit-wrought conviction in the power of its proclamation and administration as current members are discipled and new members are won by the Holy Spirit.

- ALL our **District Pastors**, especially those called here from outside the District or assigned here from one of our seminaries, who continue to carry on vital and vibrant Gospel ministry in challenging times. Many of them have also, at their monthly Circuit Meetings or Winkels, graciously welcomed the CMMFs and me as we shared in Bible study and worship. In addition, we were often asked to give a report on the continuing work of our Lord in and through the ministries of the District.
- All church workers Principals, teachers, and preschool directors; DCEs (Directors of Christian Education); DCOs (Directors of Christian Outreach); DFLs (Directors of Family Life), church musicians and the like, who train our children, enhance our lives with sound, Biblical teaching, and who continually work to remove any obstacles from the clear proclamation of the Gospel, and enrich our worship experience. I also count it a privilege to be in ministry with you, and to attend your conferences when possible.
- His goodness as seen in the vibrant presence and assured hope-filled future of Concordia University Ann Arbor (CUAA) through the partnership with Concordia University Wisconsin (CUW). We are blessed especially with



the outstanding leadership of President Patrick Ferry; Mr. Curt Gielow, Campus Executive; Rev. John Rathje, Dean of Students; and Dr. Ryan Peterson, Campus Pastor. With the addition of the North Building off of Plymouth Rd., which houses the School of Nursing, and other medical science majors like Physical Therapy, Athletic Training, and the like, our university continues to grow, and has many more opportunities of witnessing to a loving Creator and Savior.

- The willing spirit of the Registered Service Organizations (RSOs) in the Michigan District to meet together as Michigan Lutheran Leaders and Ministries (MLLM). As they meet to discuss the role that each organization has in contributing to the health and continuing vitality of God's Kingdom and then discover what we can do better TO-GETHER than we could ever imagine doing separately, we are reminded that God "... is able to do immeasurably more than all we ask or imagine, according to His power that is at work within us" (Ephesians 3:20).
- In particular, the leadership of Mr. Dave Gehm at Wellspring Lutheran Services, a dynamic social ministry (a combination of the former Lutheran Child and Family Service and Lutheran Homes of Michigan). In addition to the many services they provide around the state, they have been most gracious in supplying quality child care for our pastors' families at our All Pastors' Conferences (APCs) in the fall. We pray for, and anticipate, God's continued working through the influence and efforts of Wellspring Lutheran Services for everyone in the State of Michigan.

Your Michigan District Board of Directors (BOD) meets five times each calendar year for day-long, face-to-face meetings. The normal rhythm of our meetings is a time to hear and focus on God's Word, hear the President's report on the state of the District and the Synod, monitor the work of our wonderful district staff, receive and review financial statements and the annual audit report, address property items before us, discuss books and other materials appropriate for our growth, and review our Policy Manual and its work for guiding and supporting the District President.

Your BOD is made up of four Directors from each of the four regions of our District: two lay members, one commissioned minister, and one ordained minister. These members, along with the District President, Vice Presidents, Circuit Visitor Chairman, and District Secretary make up the BOD.

Over the last triennium, we were able to celebrate the 500th Anniversary of the Reformation together at the Breslin Center in East Lansing. This was a wonderful time to hear God's Word and to celebrate the work of our Savior Jesus Christ. Having over 13,000 of God's people together in one place was, for many, a once-in-a-lifetime celebration. We give thanks for the Holy Spirit's work among our churches; we give thanks for the staff's work in organizing this worship time; and we give thanks for CEF's support of this event. To God be the glory!

The four Critical Targets focus our district work on Great Commission Ministry, Great Compassion Ministry, Healthy Congregations, and Healthy Church Workers. By Great Commission Ministry, the BOD means letting the light of Jesus' love shine through our congregations as we "Go and Make Disciples..." by the power and blessing of the Holy Spirit. Great Compassion Ministry means the work of caring for God's people, putting our love into action, and blessing those whom Jesus loves. We mean by Healthy Congregations that each distinct congregation has a unique ministry and a different community to minister in, yet there are some

common items that allow ministry to go forth. A focus on the Word of God, unity and love among God's people, the blessing of God's people working together and the financial resources to carry out the ministry are some of the major aspects that make up healthy congregations. By Healthy Church Workers we mean that we long for our church workers to be strong in the Lord, spiritually healthy, emotionally supported when the challenges of life and ministry overwhelm them, and physically healthy so that they have the energy and physical strength to carry out their callings. The BOD monitors, prays, and works to be improving in these four areas.

Over the past three years, we have seen our Concordia University Ann Arbor's ministry grow in its work and influence in our region of the LCMS. We give thanks for Dr. Ferry and CUW's leadership and partnership and look forward to the years to come.

We have celebrated the new key staff additions in our District of Rev. Todd Jones as an Assistant to the President in the area of Mission Development. We have also welcomed Mr. Travis Grulke as the new Superintendent of our Schools. All the staff are a great blessing to our walking together as the LCMS here in the Michigan District.

We have also had some good dialogues with the CCM about bylaw items that are before our church body. The issues before our whole church are different than they were twenty years ago in our country. How do we navigate those changes? The District also functions as Synod in this place and how do we best serve the congregations and called workers of the Michigan District? These discussions and work will continue in the next few years.

Our Fiduciary responsibilities make up a big part of our work. Reviewing our financial records, discussion around our financial policies, and making sure that the properties of the District are administered wisely are all things we discuss. We spend time almost every meeting looking at the properties the District holds and making sure that when properties need to be sold, it is done wisely, fairly, and in accord with good business practices.

At the end of this Convention, we will say goodbye to many faithful servants on our Board. The positions are limited to two six-year terms. We have seen God's faithfulness in bringing new Directors with their unique gifts onto the Board. God is faithful, and God's people who serve in our Michigan District

are wonderfully faithful also! To those elected to serve on the BOD, welcome. To those coming off the Board, we will miss you and we give thanks to God for your service!

BUSINESS/FINANCE DEPARTMENT

The Michigan District of The Lutheran Church—Missouri Synod continues to be blessed with financial resources to carry out mission and ministry. The district maintains a strong financial position due to congregations continuing to support their collective work through the district, partnerships with Church Extension Fund (CEF) and other entities, and the continuing development of individual donors.

The district's net assets (equity) increased \$4,549,336 from \$12,242,958 to \$16,792,294 over the past triennium. While the District doesn't exist to build stronger financial statements, several items contribute to this increase, including the following. Approximately \$1,811,000 of the increase is the net change in assets (cash and pledges) from The Future is Now and Here We Stand capital campaigns for mission and ministry over the next several years. In addition, the District Endowment Fund increased \$866,000, including Here We Stand gifts of \$747,000. The District paid down long-term debt by \$926,000, much of that relating to the \$1.2 million loan from CEF for the District's participation the prior triennium in the combining of Concordia University Ann Arbor and Concordia University Wisconsin. The District introduced a Returnable Funding model of supporting new mission and ministry endeavors, where all or half of the mission advance is repaid (interest free) over 20 years, providing another source of cash flow for New Start endeavors in the future. Under Generally Accepted Accounting Principles, the District must record the net present value of these repayments as assets on its books. In effect, \$559,000 that previously would have been expensed under traditional mission support programs is no longer expensed and increases net assets.

Actual unrestricted cash receipts from congregations averaged \$4.7 million the past 3 years, down approximately \$175,000 from the prior triennium, and off the high of \$6.4 million in 2001. (Note the Statement of Activities shows bigger swings due to the timing of receipt of congregation commitment forms.) As is done each triennium, a detailed report of this giving is attached to this report.

During the years ending 1/31/16 and 1/31/17, the district sent 39.5% of the District/Synod congregation offerings on to Synod for national and international ministry. The district sent 35% for

the year ending 1/31/18. Over the triennium, the district directly allocated over \$4.5 million in mission work (new mission starts, urban and cross-cultural, campus ministry, world missions, etc.), including the returnable portion of support discussed above.

Following is the Statement of Financial Position and the Statement of Activities as included in the Annual Financial Statements and Independent Auditors' Report for the year ended January 31, 2018. The statement of cash flows and the notes are an integral part of the financial statements, but are not presented here. XI A1); and 8 9 WHEREAS, the Constitution of the Synod defines the scope of the ecclesiastical supervision of the President of the Synod as the officers of the Synod, all such as are employed by the Synod, the 10 11 individual districts of the Synod, and all district presidents (Art. XI B1); and 12 13 WHEREAS, the Constitution of the Synod defines the scope of the ecclesiastical supervision of 14 district presidents as the ordained and commissioned ministers of their districts (Art. XII 7) and 15 entrusts them with the power to suspend ordained and commissioned members from membership in 16 the Synod (Art. XII 8); and 17 18 WHEREAS, the Commission on Constitutional Matters (CCM) has affirmed the sole responsibility of 19 the District Presidents for ecclesiastical supervision of members in their respective districts 20 (Opinions Ag. 1970, 13-2669]; and 21 22 WHEREAS, the 2004 LCMS Convention amended the bylaws to eliminate the possibility of an 23 accuser appealing a complaint that has been terminated by a district president to the Praesidium of 24 the Synod; and 25 26 WHEREAS, the LCMS Board of Directors, following the 66th Regular LCMS Convention held in 27 Milwaukee, Wisc., amended the bylaws to provide opportunity for an accuser to appeal to the 28 President of the Synod if the District President does not suspend a member of Synod; and 29 30 WHEREAS. Bylaw 2.14.5 was added outside of a Synod Convention, contrary to Article XIV of the 31 Synod's Constitution which provides that "The Synod in convention may adopt bylaws that are 32 consistent with and do not contradict the Constitution of the Synod, which controls and supersedes 33 such bylaws and other rules and regulations of the Synod;" and 34 35 WHEREAS, Article XIV of the Synod's Constitution makes binding only those bylaws "adopted, 36 revised, or eliminated by a simple majority vote of a national convention" and not bylaws adopted by 37 any subset of the Synod, such as the Board of Directors of the Synod; and 38 39 WHEREAS, Bylaw 2.14.5 is in conflict with the Constitution of the Synod Article XI B1; and 40 41 WHEREAS, the existing LCMS Handbook now exposes the accused worker to the undue burden of 42 defending himself/herself repeatedly; therefore be it 43 44 Resolved, that the 2019 LCMS Convention be memorialized to remove Bylaw 2.14.5; and be it 45 further 46 47 Resolved, that the 2019 LCMS Convention reaffirm the method of ecclesiastical supervision adopted 48 in the Bylaw changes by the 2004 convention. 49

The purpose for which funds and assistance may be provided shall include, but not limited to, acquiring property, erecting buildings, purchasing equipment, acquiring housing and supporting projects and the operations of the above. WHEREAS, CEF also desires to clarify that all persons serving CEF (trustees, officers, employees, volunteers, etc.) are afforded the standard legal protection of indemnification consistent with Michigan law; therefore be it

Resolved, that the "Relationship to the Michigan District" section of CEF's Bylaws is hereby amended to add the following new subsection 3 [new language underlined for reference]:

I. RELATIONSHIP TO THE MICHIGAN DISTRICT

- 1. The Church Extension Fund shall be subject to the Constitution and Bylaws of the Michigan District of the Lutheran Church-Missouri Synod insofar as said Constitution and Bylaws do not conflict with the laws of the State of Michigan.
- 2. In the event of the dissolution of the Church Extension Fund as a Michigan Church Trustee Corporation, all property and assets to which it holds title, or over which it has control, shall be transferred forthwith to the Michigan District of the Lutheran Church-Missouri Synod or to its nominee.

The District convention shall elect a 12-member Nominating Committee consisting of one

ordained minister, one (1) commissioned minister, and one (1) layperson from each region of the District and the President shall designate the Chairman thereof. The three committee members from each region shall serve as the regional nominating committee.

- **b.** The Nominating Committee shall meet at the call of the Secretary.
- c. The regional nominating committee shall draw up from its region a list of candidates and alternates for the Board of Directors and the Nominating Committee in accordance with the provisions of Michigan District Bylaws 5.6, and 5.7, and 5.13 and the Schedule of Elections. The regional nominating committee shall obtain the consent of the persons it proposes to nominate, as well as biographical data, and supply the regional assembly with this information. Following the regional nominations, the biographical data of persons nominated shall be transferred to the District Nominating Committee so that the District ballot may be drawn up.
- d. The District Nominating Committee shall draw up a list of candidates and alternates for all other District offices, namely, the Secretary and the Church Extension Fund Board of Trustees. The Nominating Committee shall obtain the consent of the persons it proposes to nominate, and transmit its final report to the Secretary no later than three (3) months before the convention. This report shall contain the occupation or profession, residency, and specific experience and qualifications for the proposed office.
- **e.** The Chairman or his designate shall submit the committee's report to the District convention.
- f. If between the regional assembly and the District convention a nominee becomes ineligible for election, the Elections Committee will fill the vacancy on the ballot with the person who received the next-highest number of votes.
- g. The convention shall have the right to alter the ballot by amendment. The amendment procedure shall include a motion, a second, and a majority vote on the amendment. Any delegate making a nomination for the floor shall have secured prior written consent and biographical data from the candidate whom he wishes to nominate as detailed in Michigan District Bylaw 5.6 c. & d. This material shall then be submitted to the District Secretary.
- h. The Chairman shall have on hand at the convention a reserve list of nominees, approved by his committee, for use if required if a new board is to be elected. Whenever possible, however, the committee on nominations should be informed in advance if any new board is likely to be elected at a District convention, so that it may have a slate of candidates in readiness.

5.13 Nominations of Board of Directors.

- a. Every voting congregation of a region nominating for the Board of Directors may nominate one (1) ordained minister, one (1) commissioned minister and two (2) laypersons from its region for consideration as potential candidates by the regional nominating committee, which may consider additional candidates as it sees fit. (Cf. Bylaw 5.5 c. & d. for the nominating schedule.)
- **b.** The nominations shall be submitted to the <u>Secretary Nominating Committee</u> no later than four (4) months prior to the opening of the District convention.
- c. The Secretary Nominating Committee shall notify each nominee, secure his approval in writing, and secure biographical information for the inclusion of the prepare a slate of up to four (4) ordained ministers, four (4) commissioned ministers, and (8) laypersons receiving the most nominations on for the regional nominating ballot in accordance with Bylaw 5.6 c.

- d. At the regional assemblies each region shall choose by ballot two (2) ordained ministers, two (2) commissioned ministers, and four (4) laypersons <u>from the slate prepared by the regional nominating committee</u> as nominees for election by the District convention.
- e. Each voting delegate in the region may vote for two (2) ordained minister nominees, two (2) commissioned minister nominees, and four (4) layperson nominees. The two (2) ordained ministers, two (2) commissioned ministers, and (4) laypersons receiving the largest number of votes shall be candidates. The tellers shall report the results of the meeting to the chairman.
- f. The chairman of the regional assemblies shall report to the Secretary the names of the persons nominated for the Board of Directors, along with the biographical data. The Secretary shall transmit such names to the Floor Committee on Elections.
- g. The Committee on Elections shall recap the information provided on qualifications and experience for each candidate and shall submit such information together with the ballot on which such election is to take place.
- h. The convention shall have the right to alter the slate at the proper time by majority amendment as outlined in Michigan District Bylaw 5.6 g.
