



Youth Leader “How To” Guide

How to enroll your congregation for the 2026 Junior High Gathering in Frankenmuth.

1. CONGREGATION ENROLLMENT

Primary Adult Leader, please go to michigandistrict.org/jrhigh26 to enroll. Fill in the needed information for YOUR congregation. We are asking for an approximate number of youth and adults and number of rooms you will need. PLEASE DO THIS AS SOON AS YOU CAN! Please do not wait until the deadline. This will ensure time for us to give you your specialized link so your parents/leaders can complete their individual enrollment online and avoid the late fee (\$50 per person)! Housing at the Barvian Inn Lodge is limited and will be subject to availability. Register early to avoid being placed on a waiting list.

2. INDIVIDUAL ATTENDEE ENROLLMENT

You (the Primary Adult Leader - the contact on the congregation enrollment) will receive an email from the District Office within two weeks. The email will include **YOUR congregation's specialized link** for your individual attendees to complete their enrollment, as well as a “**Parent/Attendee How-to-Enroll**” Guide. You will then email these two items to your parents/adult leaders.

- All attendees (youth or adult) must use this specific link to enroll. Please note: in order to guarantee the early bird pricing, ALL individual attendees must enroll by April 30. If the congregation enrolls early but individuals enroll after April 30, late fees will apply.
- A Housing Form will need to be completed by the Primary Adult Leader by June 3 at 5 p.m. You will receive instructions on how to complete this form in a future communication.

3. DEADLINES

Congregation Enrollment deadline is April 30, 2026.

Individual Attendee Enrollment Early Bird deadline is April 30, 2026 - \$100/person + lodging

Individual Attendee Late Enrollment (May 1–31) - \$150/person + lodging.

Final deadline for ALL attendee enrollments is May 31, 2026, at 5 p.m.

Note - no cancellations or refunds after May 31. If a cancellation is needed before May 31, contact Debbie Cameron, CMP at debra.cameron@michigandistrict.org.

Housing form is due June 3, 2026.

Final Payment is due July 1, 2026. No payments should be sent in until after a final invoice is received so that all late fees and correct housing fees are accounted for.
